PROCEDURAL ITEMS

Mayor Allen Todd called the meeting to order at 7:00 P.M. Present were the Mayor, Mayor Pro Tempore Zane Hedgecock, Council Members, Mark Swaim, Lynn Reece, and Steve Yokeley. Councilwoman Cindy Johnson was absent. The Town Attorney, Jay Wagner was present along with, Donna Alwine, the town clerk.

After an invocation by Councilman Lynn Reece, Mayor Pro Tempore Hedgecock led the pledge of allegiance.

2. **Wall Home Update** – Councilman Mark Swaim handed out to each council member a list that was made at the special meeting held on July 16, 2020 of items in the home that will be repaired and/or replaced for the homes circa. The objective is to keep the integrity of the original Wall Home and to preserve as much of the original as possible but to replace with appropriate materials – keeping with the time period.
3. **Town Hall Park Construction** – Councilman Steve Yokeley updated that the paperwork for the bidding process on the park garage/shed are just about ready.
4. **MPO – High Point** – Councilman Reece attended the MPO meeting via telephone meeting. Nothing in regards to the town.
5. **MPO – Winston Salem** – Mayor Todd advised there was a virtual meeting – nothing in regards to the Town of Wallburg.
