The meeting was called to order at 7:01 p.m. by Mayor Allen Todd. Present for a quorum were Mayor Todd, Councilmembers Zane Hedgecock, Lynn Reece, Chris Yokeley, and Steve Yokeley. Councilman Jerry Weavil had an excused absence. Also present were Aaron Clinard, town attorney, and Lynn McKinnie, town clerk.

Also in attendance for a presentation to the council were D.O.T. Project Manager Vince Rhea and his consultants from H.W. Lochner Engineering, Chris Werner, Kristen Maseman, and Brian Eason.

Mr. Hedgecock gave a brief Invocation and Mr. Steve Yokeley led the Pledge of Allegiance.

MOTION FOR APPROVAL OF AGENDA

A motion for approval of the agenda, which included amending the agenda by moving the D.O.T. presentation ahead of the Budget Presentation, was made by Chris Yokeley, seconded by Steve Yokeley and unanimously approved.

NC D.O.T. Project Development & Environmental Analysis Discussion/Update of Highway 109

Mayor Todd opened the informational presentation by telling the audience that the people present tonight were from the North Carolina Department of Transportation and were here to provide the Town Council with an update on

what the process and progress of the NC-109 project is. Questions will be answered from the Town Council following their presentation. He introduced the quests:

The meeting recessed for five minutes to allow the D.O.T. people to clean up.

2. PUBLIC HEARING

Fiscal Year 2006-2007 Town of Wallburg Budget Presentation Mr. Chris Yokeley gave a brief informational presentation on the 2006-2007 Budget. Some of his points were:

- There is an increase under Income from last year from \$422,000 to \$485,000 projected income.
- That increase, in no way, constitutes any type of tax increase!
- That strictly comes from the increase in spending on sales tax.
- Our tax rate will remain the same 5-cents per \$100 the minimum as required by the state of North Carolina.
- Items #4, 5, 6, and 7 have a zero amount because they are lumped in under the property tax. He will try and get a break-out of these taxes for next year's budget.
- There's not a lot of changes from last year to this year in expenses.
- Line #14 Local Education Subsidy this was recommended by Stan Bingham to give back to the community – the local school system. We're not just giving them \$10,000 to spend – there will be a system of checks and balance to ensure the money does go to the students.
- Line #15 Davidson County Economic Development Subsidy this is not to promote the development of Wallburg, per se. This money will go to the County to help promote the economic development of Davidson County. If they do well, we do well!
- Line #32 Accounting Audit The savings from last year to this year, went to the Davidson County Economic Development Subsidy and to the Local Education Subsidy. So it was money well-saved and money well spent.
- Line # 34 and #35 (Property Fund and Building Fund) Last year they
 were combined; this year we split them up. One of the big things we are
 looking at is property and, eventually, a town hall --- so we separated
 those.

Other than those changes, the budget is very similar to last year's.

The PUBLIC HEARING was opened at 7:57 p.m. Mayor Todd explained that there is a list of items in reference to the money to be used for the schools. We are in contact with Wallburg School – with their principal, their faculty and staff. They have provided us a list of items that they would like the money to be appropriated for. We have \$10,000 in our budget and the council will look at the list and make a decision on what to buy. Mr. Hedgecock asked if we're going to

pick items to pay for and then they will give us a report back? Mayor Todd said we're not, at this point, going to write a check out to the school system — that once the budget is in place, it will allocate a certain amount of money to be spent on items that the Town Council will determine should be purchased. With no one requesting to speak, the PUBLIC HEARING was closed at 8:02 p.m.

Mr. Dean Coe said the Meadowlands developers have asked to be at the Planning Board meeting next Monday. This is a rezoning of an 18-acre tract that they bought. What they are wanting to do is rezone the 18-acres to the same classification as the earlier portion of Meadowlands. Mr. Coe said the Planning Board intends to come with a recommendation for the Town Council at the July meeting.

Mayor Todd requested that the Clerk place an ad for a "Notice for a Public Hearing in reference to the Meadowlands zoning part of their parcel of land, an 18-acre tract, as per Dean Coe" in the newspaper.

in the Lexington, Kernersville and Winston-Salem papers. The hand-out gives the
charges for advertising for area newspapers. It was motioned that the WinstonSalem and High Point papers are the more prevalent papers being read by
Wallburg citizens.
